### **DIRECTIONS FOR USE:**

Feed SHUR-GAIN sheep ration free-choice.

**CAUTION**: The safety of Lasalocid for use in unapproved species has not been established. Do NOT allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal. For Type A and Type B feeds (cattle and sheep): mix thoroughly with grain and/or roughage products prior to feeding. Feeding undiluted or having mixing errors may result in excess Lasalocid concentration which could be fatal to cattle and sheep. In addition, inadequate mixing (recirculation or agitation) of liquid Type B feed may result in an excess Lasalocid concentration which could be fatal to cattle and

**LIMITATIONS**: In Type C feeds; for sheep maintained in confinement; feed continuously in complete feed to provide not less than 15 mg nor more than 70 mg of lasalocid sodium activity per head per day depending on body weight.
